1. OFFICER REPORTS

President Ed Harms welcomed everyone remotely by phone.

Another piece of news.... Members may recall touring Clean Harbors incinerator during the 2012 annual NE SWCS meeting. The facility is expanding and will be twice the original size as it was in 2012.

I do not have anything else to report.

*Carbon America, the first vertically integrated carbon capture and sequestration (CCS) super developer, announced an agreement with Bridgeport Ethanol, LLC to develop a carbon capture and storage project in Nebraska. The project will capture and store approximately 175,000 tons of carbon dioxide (CO₂) per year, equivalent to 95 percent of total emissions from the ethanol

facility's fermentation process. This is the first commercial project of its kind in the state of Nebraska.

OLD BUSINESS: SWCS and SRM Chapters in Nebraska are still considering the possibility of having a joint technical meeting sometime.

NEW BUSINESS: Patrick Cowsert does not want to stay on as the Northeast Director. Laura Rubeck has indicated to Claudia she would accept this position to be the Northeast Director.

Claudia has agreed to stay on as President and the same for the other officers. Claudia and Doug made the motion to approve by unanimous ballot our current held offices. Motion approved.

REGIONAL REPORT: Keith Berns gave us his report on the Northwest region we belong to. He has been to a number of meetings and would like to hear from us if we have ideas of getting several states together for a joint technical meeting. He did indicate that many states and Ankeny are amazed that Nebraska can offer the scholarships we do.

SILENT AUCTION: Darwin thanked everyone for participating in the auction. Corey said we made \$525 on it. This is used for the scholarships we offer.

AWARDS: The following awards were given out by the Awards Committee.

National Awards: Claudia Stevenson and Jim Culver will be receiving the Society Service Award. John Gilley will be getting the Fellow Award. Zamir Libohova formerly from Lincoln and now with the USDA ARS in Arkansas, was give honorable mention for Best Research Paper for Impact and Quality Award. Our Nebraska Chapter will be receiving the Outstanding Chapter Award and the Exceptional Chapter Event Award for our Legislative Breakfast event.

Nebraska Chapter Awards:

Dick Ehrman received the State Commendation Award. Mike McDonald got the Nebraska Innovation Award. Joanna Pope received the Nebraska Honor Award. The Lower Platte South NRD received the State Merit Award. Jim Barr and Paul Zillig received the State Commendation Award.

SCHOLARSHIPS: Corey made the motion and Jim seconded it to have two scholarships from the UNL Foundation and two from the golf tournament. Each scholarship was for \$1,000. Approved.

GOLF: The golf tournament will be held at Highland Golf Course in Lincoln on September 8.
