### Nebraska SWCS Annual Meeting in Ainsworth

The Nebraska Soil & Water Conservation Society held its annual meeting in Ainsworth, NE., June 11-13. Registration and the Wednesday evening meal were held at the Ainsworth Golf Course.

Mayor Russ Moody welcomed the group Thursday morning at the Ainsworth Conference Center, and Wally Valasek, SWCS President, opened the meeting. A history of north central Nebraska, grassland usage and ranching changes was presented. The speakers focused on how different climatic, economical, and environmental factors shaped the Niobrara Valley. Local Rancher Sid Salzman described his operation. Cort Dewing, NE School Lands representative, spoke on school lands policies on grazing and wildlife. Dennis Bauer spoke to the group about the Barta Brothers Univ. of NE, Extension Research Ranch, and Paul Hedron of the National Parks Service spoke on the Niobrara Scenic River plan.

The Nebraska business meeting begain with election of officers for next year. It was noted that the chapter was very successful in hosting the Conservation Planning for Excellence Workshop that was held last November. The NE chapter also hosted the Northern Plains Chapter Development Workshop in March. Three scholarships of \$750 each was presented to college students this past year. Next years meeting will be in Northeast NE. The upcoming National Meeting in Spokane was also discussed.

A program was presented by Sheila Chance of Niobrara Valley Woodworking Products. The group then traveled to Sawle's Sawmill North of Meadville for a tour. The Sawle's own and operate a local sawmill. They specialize in producing lumber from Cedar and Pine trees that grow in the Valley. Several homes throughout the area and NE have installed cedar siding, produced at the mill.

Before the tour we met the family group who had spent the day shopping the local antique shops and touring the homes that where constructed using local lumber products.

That evening a pitchfork steak supper was held at the Meadville Park followed by the presentation of awards and entertainment.

Friday morning the group traveled to Nature Conservancy's Niobrara Valley Preserve. During a tour of the preserve the group viewed the bison herd while discussions covered how the herd is managed. The Bison are allowed to roam in a 7,000 acre pasture. They also viewed cedar harvesting, burn areas and a post peeler demonstration. The meeting concluded following lunch at the visitor center.

### **NRCS Buffer Assistance Dedication**

NRCS has provided technical assistance for a riparian restoration project and for a variety of buffer and related practices. All practices were used in construction of the new Lied greenhouse, Learning Pavilion, and golf course dedicated on Arbor Day at Arbor Day Farm in Nebraska City, Nebraska. NRCS Northern Plains Regional Conservationist Richard Van Klaveren was among the speakers at the dedication.

NRCS was one of several public and private institutions that worked with the National Arbor Day Foundation in conceptualizing and constructing the conservation learning center, which features a component on the use of trees in rural landscapes. An area of the learning center showcases riparian buffers, windbreaks, shelterbelts, and living snow fences and the many conservation benefits that can be achieved through their use. The new greenhouse is a state-of-the-art facility in which the foundation expects to grow as many as 300,000 tree seedlings annually.

Completed this summer, a "tree-house" trail adjacent to the learning center features a handicapped-accessible tree house that enables trail users to view the South Table Creek riparian corridor from above. Conservation education programs at Arbor Day Farm annually attract more than 15,000 students from surrounding schools.

### **Workday Thanks and Display Update**

First, many, many thanks to you early morning risers in August that helped cut back the 'overhangers' and clean up weeds, etc. at the Native Plant Display (in front of the 4-H Building) prior to Nebraska State Fair. Members Lyle Steffen and Craig Romary made it all worth waking up for. Also, more thanks to anyone who found the time to just stop by and pull/spray weeds throughout the growing season. The display received real nice comments from passersby before and during the fair. A wide variety of people, from the experienced to the young (even a couple of carnival workers), stopped by to compliment our efforts in plant education and landscape use of native plants. Kudos on the site are received frequently, even though the display has it's 'wanting' areas.

In related news - State Fair Manager Pat Lloyd has hired (back) Bob Henrickson as a very part-time consultant to the affairs of the grounds of State Fair Park Arboretum (which is really all of the fairgrounds - 325 acres). Bob worked there as Grounds Supervisor/Curator for much of the 1990s and is now Asst. Director for Horticulture for the Nebraska Statewide Arboretum at UN-L. He and his crew handled the display pretty much on their own until he left about 2000. Thereafter, as has been said, it has needed our assistance again.

Mr. Lloyd has talked about a redesign to better suit his vision of a native landscape which is more maintenance-free and eye-appealing. To this end, 'Grass Plot' Liaison Julie Lamphere will be meeting with Bob and Mr. Lloyd in the near future. A peek at what he's thinking? Fewer species overall, and the planting of those that stand up (literally) on their own with little manipulation to be attractive. Plants could include little bluestem, sideoats grama, purple poppymallow and butterfly milkweed.

### **SWCS NE CHAPTERS SCHOLARSHIP FUNDS**

The Nebraska chapters, Nebraska and Northeast, have two Foundations which provide scholarships to college students interested in the broad natural resources field

University of Nebraska Foundation, Nebraska Chapter, Soil and Water Conservation Society. The University of Nebraska Foundation - Nebraska SWCS endowment fund was established in 1973 for providing scholarships to college students interested in the natural resources field. Dollars from our Nebraska chapters and from other donors are invested in this Foundation. Scholarships are awarded only from earnings of this investment. The dollar amount of the scholarships (which can not exceed the amount of earnings) given each year is decided at the Nebraska chapters annual business meeting. Eligible students are "regularly enrolled undergraduate students in the UN-Lincoln, Omaha, Kearney or NCTA campus."

The fund balance as of May 31, 2003 was \$12,681.87. Of this total, \$1,513.86 was investment income that is available for scholarships. For the 2003-2004 year, the UN-L Foundation SWCS Fund has been budgeted at \$1000 by the Nebraska Chapter. During the annual business meeting at Ainsworth, the Nebraska chapters voted to provide two \$750 scholarships for the 2003-2004 year.

Nebraska Soil and Water Conservation Foundation (NSWCF). The NSWCF was created in 1988 with the purpose of promoting and supporting special activities in education, public information and research. It is a part of the Nebraska and Northeast Nebraska Chapters. Dollars from our Nebraska chapters and from other donors are invested in this Foundation. The Foundation may use both principal and earnings for the projects which are selected by the Foundation's Board of Directors. In recent years they have been giving a college scholarship which may be used at any Nebraska college, although the students have usually been attending the University of Nebraska - Lincoln.

The Nebraska Chapter for the 2003-2004 year has budgeted \$1,000 for the NSWCF general fund. The NSWCF at their annual business meeting at Ainsworth voted to provide one \$750 scholarship for the 2003-2004 year. The amount budgeted by the Nebraska chapters for each foundation and the amount awarded to students each year are not necessarily identical amounts. The method of presentation of the scholarships is different for the two Foundations. The officers of the NSWCF present the check in person to the recipient. The recipients of the UNL Foundation scholarship have the money deposited directly in their student account at UNL.

In recent years, Paul Smith has led the committee that selects the students. Applications are generally due about December 1st. Selections are made and announced before the end of December. Both Foundations use the same scholarship applications and selection committee.

2004 Annual meeting, Charley visited with Jan Jorgensen. Northeast Chapter will host meeting in Norfolk. No one has agreed to take charge of it yet. It is proposed that 2005 meeting be held in the Panhandle. No offers from Northeast chapter as members have been moving.
